The NSPC Party is committed to creating an environment of open and meaningful discussion so that everyone can participate in political discussion. This code of conduct reflects our **Vision, Mission,** and **Values.** 

#### Vision

Progressive Conservatives see a Nova Scotia that is an economic, social, and environmental leader for others in the world to follow.

#### **Mission**

Our mission as Progressive Conservatives is to form a fiscally responsible, socially progressive government that promotes individual achievement and personal responsibility, is accountable to its citizens, listens to its people, embraces innovation, preserves the best of our unique heritage and diverse cultures, and learns from the past.

### **Values**

- **Responsibility** defining good government as one that lives within its means and whose leaders spend a tax dollar as if it were their own
- Accountability expecting government at all levels to answer to the people for the decisions made

# **Code of Conduct Committee**

The Code of Conduct Committee is appointed by the NSPC Executive to receive all complaints that may breach the Code of Conduct.

## **Code of Conduct Intent**

- Aligns with our Vision, Mission, and Values.
- Applies to interactions involving political activities, not limited to social media, meetings and party events.

## **Expected Behaviours**

NSPC Party members are expected to:

- Participate in PC Party events in a manner that reflects our Vision, Mission, and Values and is consistent with this Code.
- Treat each other with dignity, fairness, and compassion to foster a positive, proactive, and respectful culture, and not bring the NSPC Party into disrepute.
- Include and respect diversity and inclusion practices.
- Communicate in a respectful manner in all interactions without abuse, harassment, and discrimination, including but not limited to social media posts.
- Engage in transparent and cooperative discussion.
- Adhere to the NSPC Party privacy protection requirements.

## **Resolution Process**

It is the intent of the NSPC Party to endeavour to resolve any unacceptable behaviour in a manner that is consistent, fair and in accordance with this Code and our **Vision, Mission,** and **Values.** 

- Any breach of the Code of Conduct needs to be addressed in a timely manner.
- Many situations may be dealt with by pointing out the situation and discussing it with the person or persons involved to resolve amicably.
- If the behaviour is not resolved, the complainant may choose to bring the issue to the attention of the Code of Conduct Committee where it will be addressed in a procedural manner and process.
- The Committee will act in its sole discretion, taking into account the significance of timeliness, confidentiality, transparency, fairness and professionalism, as it deems appropriate.
